

Highlights

The Total Data Quality Score for August maintained an exceptional 99.99%, reflecting continued excellence in performance. This achievement was accompanied by a notable reduction in check failures, which decreased to 129 by the end of the month. Additionally, the number of LEI issuers achieving Expected and Excellent Data Quality increased compared to the previous period. Moreover, the Average Days to Close a Challenge was significantly reduced to 14 days, highlighting a more streamlined and efficient resolution process.
