
## Summary




#### Highlights

The LEI issuers Achieving Maturity Level 2 remained stable at 47% in February, indicating that 18 LEI issuers successfully met the Expected Quality standards. Notably, Expected Quality can only be attained if the preceding Required Quality requirements have been fully met. This consistent performance underscores the adherence of the LEI issuers to the established data quality framework.
