


Summary

Highlights

The Total Data Quality Score (TDQS) for January remains strong at 99.99 reflecting the high standards in the system. The total number of check failures has dropped from 600 to 292 compared to the previous period. The count weighted with the respective Maturity Levels to the failing checks, is the primary factor driving the TDQS measurement.
