

Highlights

In October 2024, GLEIF made significant strides in enhancing data quality standards, implementing 35 new and updating 26 existing checks. These refinements focus on strengthening Translation, Transliteration, and ensuring more accurate level 2 reporting. This initially caused a slight decrease in the Average Total Data Quality Score to 99.96 and a decline in the number of LEI issuers across all the Quality Rates. However, a positive shift was observed toward the end of the reporting period, with the Total Data Quality Score rebounding to 99.98.
