Average Days to Close a Challenge | compared to the previous month


Highlights

In September 2024, the Total Data Quality Score (TDQS) and the Maturity Levels achieved by LEI issuers remained stable, underscoring the ongoing commitment to maintaining high data standards. Significant progress was made in addressing long-standing challenges, with 7,163 challenge items processed. This increased activity led to a temporary rise in the Average Days to Close a Challenge, now at 39 days.

As we approach an update to the underlying Rule Setting, a brief fluctuation in performance and key KPIs is expected. However, this adjustment will pave the way for stronger, long-term improvements in data quality.
